

BUZU OPEN INVITATION CHALLENGE

OFFICIAL TERMS & CONDITIONS

Last Updated: January 2026

1. Sponsor

The Buzu Open Invitation Challenge (the “Challenge”) is sponsored by Buzu Trading Cards and The Buzu Foundation (collectively, “Buzu,” “Sponsor,” “we,” “us,” or “our”).

2. Eligibility

The Challenge is open to individuals of any age. Participants under the age of 18 must have permission from a parent or legal guardian. Employees, contractors, and immediate family members of Sponsor may participate but are not guaranteed selection.

3. No Purchase Necessary

No purchase, payment, or pledge is required to enter or be selected. Making a purchase or pledge does not increase the chances of winning.

4. Entry Method

Participants must submit original character artwork through the submission method specified by Sponsor. All submissions must be received by the stated deadline. Late, incomplete, or improperly formatted entries will be disqualified.

5. Originality & Ownership

By submitting an entry, the participant represents and warrants that the artwork is entirely original, does not infringe upon the rights of any third party, and has not been generated in violation of copyright, trademark, or intellectual property laws.

6. Intellectual Property Rights

By submitting an entry, the participant grants Sponsor a perpetual, irrevocable, worldwide, royalty-free license to use, reproduce, modify, adapt, publish, translate, distribute, display, and create derivative works from the submission for educational, promotional, marketing, and commercial purposes. Selected designs may be further modified to meet brand, age-appropriateness, or production requirements.

7. Selection & Judging

All selections are made solely at the discretion of Mr. Guera, representing Sponsor. Decisions are final, binding, and not subject to appeal. Feedback on submissions is not guaranteed.

8. Disqualification

Sponsor reserves the right to disqualify any entry that is late, unclear, offensive, inappropriate for children, plagiarized, generated unlawfully, or inconsistent with the Buzu brand or mission.

9. Winner Notification

Potential winners will be contacted using the information provided during submission. If a selected participant (or guardian) fails to respond by the stated deadline, Sponsor reserves the right to select an alternate entry or declare the month vacant.

10. Prizes

Prizes, if any, are non-transferable, have no cash value unless explicitly stated, and may be substituted at Sponsor's discretion. Sponsor is not responsible for lost, damaged, or delayed prizes.

11. Taxes

Participants are solely responsible for any federal, state, or local taxes associated with prizes.

12. Publicity Release

By participating, entrants grant Sponsor permission to use their name, likeness, artwork, and statements for promotional purposes without additional compensation, except where prohibited by law.

13. Limitation of Liability

Sponsor is not responsible for technical failures, lost submissions, or any damages arising from participation. Participants agree to release and hold harmless Sponsor from any claims arising out of participation or use of submissions.

14. Indemnification

Participants agree to indemnify and defend Sponsor against any claims arising from breach of these Terms or infringement of third-party rights.

15. Privacy

Personal information collected will be used solely for administration of the Challenge and in accordance with Sponsor's privacy practices.

16. Right to Modify or Cancel

Sponsor reserves the right to modify, suspend, or cancel the Challenge at any time for any reason without prior notice.

17. Governing Law

These Terms are governed by the laws of the State of Texas, without regard to conflict-of-law principles.

18. Severability

If any provision is found unenforceable, the remaining provisions shall remain in full force and effect.

19. Acceptance of Terms

Participation constitutes full and unconditional acceptance of these Terms & Conditions.
